Translation of the original instructions.

 This product may be used under supervision, or if instruction regarding the safe use of the product has been provided and the resulting dangers have been understood, by children aged 8 and above, as well as by persons with physical, sensory or mental

disabilities or a lack of experience and knowledge. Children must not be allowed to play with the product. Cleaning and user maintenance must not be performed by children without supervision. The use of this product by young people under the age of 16 is not recommended.

Intended use:

The **GARDENA Balkony Watering/Extended Watering Set Water Container** is intended for fully automatic watering of flower boxes, independent of the water supply. The pump is completely submersible (watertight encapsulation) and is submerged in the water (to a max. depth of see 8. TECHNICAL DATA).

The product is not intended for continuous operation.

DANGER! The pump should not be used for the delivery of salt water, muddy water, corrosive, easily inflammable or explosive liquids (e.g. petrol, paraffin, thinners), oil, heating oil or foodstuffs.

1. SAFETY

IMPORTANT!

Read the operator's manual carefully before use and keep for future reference.

General safety warnings

DANGER! Electric shock!

Risk of injury due to electric shock.

The product must be supplied through a residual current device (RCD) having a rated residual operating current not exceeding 30 mA.

Safe operating practices

The water temperature should not exceed 35 °C.

The pump must not be used when people are in the water.

Leaking lubricants can contaminate the pumped liquid.

Circuit breakers

Dry-running protection: If no water is pumped (under-current) the pump switches off automatically.

→ Refill the container with water.

Anti-lock protection: If the motor blocks (overcurrent), the pump switches off automatically.
→ Contact the GARDENA Service.

DANGER! Cardiac arrest!

This product makes an electromagnetic field while it operates. This field may under some conditions interfere with active or passive medical implants. Risk of injury due to electric shock if the pump is connected directly to the mains.

→ Connect the pump only via the watering control supplied.

Check the watering control housing for damages before usage. Don't use a damaged watering control.

Please regularly check the connecting line.

Before using, always subject the pump to a visual inspection.

A pump which is damaged should not be used. In the event of damage, have the pump checked by GARDENA Service.

Damaged connecting cables to the pump can only be replaced by the GARDENA Service.

Disconnect the watering control from the outlet socket for all work on the balcony watering.

The pump may only be operated with 14-V protected low-voltage in combination with the GARDENA watering control for pump.

Protect from rain. Use the watering control for pump only in a rain-protected area.

Only use Original GARDENA parts, as the function of the system cannot otherwise be guaranteed.

Do not let the pump run dry.

Observe the minimum water level in accordance with the Technical Data given for the pump.

Do not use the product while you are tired or under the influence of drugs, alcohol or medication. A moment of inattention while you operate the product may result in serious personal injury.

Do not open the pump further than delivery status (only exception: the foot).

Personal safety



DANGER! Risk of suffocation!

Small parts can be easily swallowed. There is also a risk that the polybag can suffocate toddlers. Keep toddlers away when you assemble the product.

2. SCOPE OF DELIVERY

[Fig. D1]:

- ① 1 x Watering control for pump with 14 fixed watering programs
- ② 1 x Submersible pump (operating voltage 14 V)
- ⑤ 1 x Inline Drip Heads, 2 l/h

Art. 1407:

- ③ 10 m Supply Pipe Ø 4.6 mm (3/16")
- ④ 15 x Pipe Pegs Ø 4.6 mm (3/16")
- ⑤ 24 x Inline Drip Heads, each 2 l/h
- ⑥ 3 x Sleeves
- ⑦ 2 x End Caps (for water pump)
- ⑧ 1 x Cleaning Needle
- ⑨ 3 x End Caps (for Supply Pipe)

3. INSTALLATION



DANGER! Risk of injury!

Injury when the product starts accidentally.

→ Disconnect the product from the mains before you install the product.

→ You need a container with a capacity of more than 8 litres (as some water evaporates from the container in 10 days).

The corresponding watering program can be taken from the program table (see 4. OPERATION).



CAUTION!

If the required container exceeds 100 litres, you must observe the max. weight load of your balcony (according to DIN 1055).

To calculate the water quantity and container size:

The Flower box watering set allows up to 25 plants (when using one drip head per plant) to be irrigated to a maximum length of 10 m.

With the accessories from the **GARDENA Micro-Drip**

System (supply pipe, pipe pegs and drip heads), a max. of 40 drip heads may be connected to the pump. The supply pipes must be distributed to all 3 connections of the pump.

Example calculation:

- You have **8 plants** (e.g. in 2 flower boxes) and each plant should be watered with **a drip head**.
- Each plant should be irrigated **once a day with 0.1 litres**.
- The amount of water should last for **10 days**.

$$8 \text{ (drip heads)} \times 0.1 \text{ litres} \times 10 \text{ (days)} = 8 \text{ litres}$$

To connect the supply pipes to the pump

[Fig. I1/I2]:

The pump has 3 connections ⑩ for supply pipes ③.

1. Slide the sleeve ⑥ onto the supply pipe ③.
 2. Slide the supply pipe ③ onto one of the three connections ⑩.
 3. Screw the sleeve ⑥ onto the connection ⑩.
- Screw the end caps ⑦ onto the unused connections ⑩.

To connect the drip heads to the supply pipes [Fig. I3]:



CAUTION!

The first drip head should be placed directly above the water surface in the container (see Fig. O2/O3). This serves to ventilate the system and prevents any after-running of the water after the system has been switched off, especially in the case of drip heads located below the water level.

1. Cut off the supply pipe ③ vertically at the installation point of the drip head ⑤.
2. Slide the supply pipe ③ fully onto the connection of the drip head ⑤.

3. Slide the other end of the supply pipe ③ fully on the other connection of the drip head ⑤.
4. Repeat steps 1 to 3 until all drip heads ⑤ are connected.
5. Slide the end cap ⑨ onto the free connection of the last drip head ⑤.

To assemble the pipe pegs [Fig. O2]:

We recommend the assembly of 3 pipe pegs per 1 m long flower box.

1. Insert the tube holders ④ in the desired positions in the soil of the flower box.
2. Clamp the supply tube ③ into the pipe pegs ④.

4. OPERATION

Watering programs [Fig. O1]:

The watering programs can be set by the rotary switch ⑪ on the watering control. The watering duration is repeated at the set watering frequency.

To start the watering [Fig. O1/O2/O3]:



CAUTION!

Damage to the pump if it runs dry.

→ Make sure that the container is always sufficiently filled with water.

1. Fill the container with the previously calculated amount of water (make sure that the container is in a secure position).
2. Place the pump in the container filled with water (make sure that the pump is level with the bottom of the container).
3. Turn the rotary switch ⑪ to the OFF position.

4. Connect the pump ② to the watering control ①.
5. Plug the watering control ① into an electrical outlet.
6. Turn the rotary switch ⑪ to the desired watering program.
The watering starts and the control lamp ⑯ illuminates green.

7. During the first watering, check all connections for leaks.

If the watering program is to be changed, the rotary switch ⑪ must first be turned to the **OFF** position.

5. MAINTENANCE

To clean the pump:



DANGER! Risk of injury!

Risk of injury and risk of damage to the product.

- Do not clean the product with a water jet (in particular high-pressure water jet).
- Do not clean with chemicals including petrol or solvents. Some can destroy critical plastic parts.
- Clean the pump with a damp cloth.

To clean the filter [Fig. M1]:

In order to ensure continuous trouble-free operation, the filter ⑭ should be cleaned at regular intervals.

1. Push in the two locks ⑫ and pull off the foot ⑬ downwards.
2. Clean the filter ⑭ and the foot ⑬ under running water.
3. Reassemble all parts in reverse order. Make sure that the two locks ⑫ are correctly engaged.

The pump must not be operated without the filter ⑭.

To clean the watering control:

Make sure that the surface and the contacts of the watering control always are clean and dry before you connect the watering control.

Do not use running water.

- Clean the contacts and the plastic parts with a soft and dry cloth.

6. STORAGE

To put into storage:

The product must be stored away from children.

1. Disconnect the watering control.
2. Clean the pump and the watering control (see 5. MAINTENANCE).
3. Store the pump and the watering control in a dry, enclosed and frost-free place.

Disposal:

The product must not be disposed of to normal household waste. It must be disposed of in line with local environmental regulations.

Problem	Possible Cause	Remedy
The system runs after the pump has been switched off	Drip heads are below the water surface.	→ Place the first drip head above the water surface.
Pump is running but the delivery drops suddenly	Foot/Filter is clogged.	→ Clean the foot/filter.
Control lamp ⑯ on the watering control does not illuminate [Fig. O2]	Watering control is disconnected.	→ Connect the watering control.

Problem	Possible Cause	Remedy
Control lamp  on the watering control illuminates red [Fig. O2]	Pump is disconnected.	→ Connect the pump to the watering control.
Control lamp  on the watering control flashes red every second [Fig. O2]	Pump is blocked (overcurrent).	→ Contact the GARDENA Service.
Control lamp  on the watering control flashes red every half second [Fig. O2]	Container is empty (dry-running protection).	→ Fill the container with water.
