Product description


Husqvarna 525iHE3, 525iHE4 are battery pole hedge trimmers with electrical motors.

There is no electrical insulation in this product. If the product touches or comes near high voltage power lines, it can cause serious injury or death to the operator. Electricity can move between different objects by a curve. The highter the voltage, the longer the electricity can move. Electricity can also move through branches and other objects, especially if the object is wet. Always keep a distance at a minimum of 10 m/33 ft between the product and high voltage power lines and/or objects that touches the power lines. If it is necessary to do work near the power lines, make sure that the power is off before you start the work. Keep a distance at a minimum of 15 m/50 ft to other persons or animals during the operation.

Safety

Safety definitions

Warnings, cautions and notes are used to point out specially important parts of the manual.



WARNING: Used if there is a risk of injury or death for the operator or bystanders if the instructions in the manual are not obeyed.



CAUTION: Used if there is a risk of damage to the product, other materials or the adjacent area if the instructions in the manual are not obeyed.

Note: Used to give more information that is necessary in a given situation.

General machine safety warnings



WARNING: Read all safety warnings and all instructions. Failure to follow the warnings and instructions may result in electric shock, fire and/or serious injury.

Save all warnings and instructions for future reference. The term "machine" in the warnings refers to your mains-operated (corded) machine or battery-operated (cordless) machine.

Work area safety

- Keep work area clean and well lit. Cluttered or dark areas invite accidents.
- Do not operate machine in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Machines create sparks which may ignite the dust or fumes.
- Keep children and bystanders away while operating a machine. Distractions can cause you to lose control.

Electrical safety

- Machine plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) machines. Unmodified plugs and matching outlets will reduce risk of electric shock
- Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators. There is an increased risk of electric shock if your body is earthed or grounded.
- Do not expose machines to rain or wet conditions.
 Water entering a machine will increase the risk of electric shock
- Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the machine. Keep cord away from heat, oil, sharp edges or moving parts. Damaged or entangled cords increase the risk of electric shock.
- When operating a machine outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock.
- If operating a machine in a damp location is unavoidable, use a residual current device (RCD) protected supply. Use of a RCD reduces the risk of electric shock.

- Dress properly. Do not wear loose clothing or jewellery. Keep your hair and clothing away from moving parts. Loose clothes, jewellery or long hair can be caught in moving parts.

Power tool use and care

- Do not force the power tool. Use the correct power tool for your application. The correct power tool will do the job better and safer at the rate for which it was designed.
- Do not use the power tool if the switch does not turn it on and off. Any power tool that cannot be controlled with the switch is dangerous and must be repaired.
- Disconnect the plug from the power source and/or remove the battery pack, if detachable, from the power tool before making any adjustments, changing accessories, or storing power tools. Such preventive safety measures reduce the risk of starting the power tool accidentally.
- Store idle power tools out of the reach of children and do not allow persons unfamiliar with the power tool or these instructions to operate the power tool.
 Power tools are dangerous in the hands of untrained users.
- Maintain power tools and accessories. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use. Many accidents are caused by poorly maintained power tools.
- Keep cutting tools sharp and clean. Properly
 maintained cutting tools with sharp cutting edges are
 less likely to bind and are easier to control.
- Use the power tool, accessories and tool bits etc. in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the power tool for operations different from those intended could result in a hazardous situation.
- Keep handles and grasping surfaces dry, clean and free from oil and grease. Slippery handles and grasping surfaces do not allow for safe handling and control of the tool in unexpected situations.

Battery tool use and care

- Recharge only with the charger specified by the manufacturer. A charger that is suitable for one type of battery pack may create a risk of fire when used with another battery pack.
- Use power tools only with specifically designated battery packs. Use of any other battery packs may create a risk of injury and fire.
- When battery pack is not in use, keep it away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects, that can make a connection from one terminal to another.

- Shorting the battery terminals together may cause burns or a fire
- Under abusive conditions, liquid may be ejected from the battery; avoid contact. If contact accidentally occurs, flush with water. If liquid contacts eyes, additionally seek medical help. Liquid ejected from the battery may cause irritations or burns.
- Do not use a battery pack or tool that is damaged or modified. Damaged or modified batteries may exhibit unpredictable behavior resulting in fire, explosion or risk of injury.
- Do not expose a battery pack or tool to fire or excessive temperature. Exposure to fire or temperature above 130 °C (265 °F) may cause explosion.
- Follow all charging instructions and do not charge the battery pack or tool outside the temperature range specified in the instructions. Charging improperly or at temperatures outside the specified range may damage the battery and increase the risk of fire

Service

- Have your power tool serviced by a qualified repair person using only identical replacement parts. This will ensure that the safety of the power tool is maintained.
- Never service damaged battery packs. Service of battery packs should only be performed by the manufacturer or authorized service providers.

Hedge trimmer safety warnings

- Keep all parts of the body away from the blade. Do not remove cut material or hold material to be cut when blades are moving. Blades continue to move after the switch is turned off. A moment of inattention while operating the hedge trimmer may result in serious personal injury.
- Carry the hedge trimmer by the handle with the blade stopped and taking care not to operate any power switch. Proper carrying of the hedge trimmer will decrease the risk of inadvertent starting and resultant personal injury from the blades.
- When transporting or storing the hedge trimmer, always fit the blade cover. Proper handling of the hedge trimmer will decrease the risk of personal injury from the blades.
- When clearing jammed material or servicing the unit, make sure all power switches are off and the battery pack is removed or disconnected.
 Unexpected actuation of the hedge trimmer while clearing jammed material or servicing may result in serious personal injury.
- When clearing jammed material or servicing the unit, make sure all power switches are off and the lock-off is in the locked position. Unexpected actuation of the hedge trimmer while clearing jammed material or servicing may result in serious personal injury.
- Hold the hedge trimmer by insulated gripping surfaces only, because the blade may contact

- **hidden wiring.** Blades contacting a "live" wire may make exposed metal parts of the hedge trimmer "live" and could give the operator an electric shock.
- Keep all power cords and cables away from cutting area. Power cords or cables may be hidden in hedges or bushes and can be accidentally cut by the blade.
- Do not use the hedge trimmer in bad weather conditions, especially when there is a risk of lightning. This decreases the risk of being struck by lightning.

Extended-reach hedge trimmer safety warnings

- To reduce the risk of electrocution, never use the extended-reach hedge trimmer near any electrical power lines. Contact with or use near power lines may cause serious injury or electric shock resulting in death.
- Always use two hands when operating the extendedreach hedge trimmer. Hold the extended-reach hedge trimmer with both hands to avoid loss of control.
- Always use head protection when operating the extended-reach hedge trimmer overhead. Falling debris can result in serious personal injury.

General safety instructions



WARNING: Read the warning instructions that follow before you use the product.

- Remove the battery to prevent the product from being started by accident.
- This product is a dangerous tool if you are not careful or if you use the product incorrectly. This product can cause serious injury or death to the operator or others.
- Do not use the product if it is changed from its initial specification. Do not change a part of the product without approval from the manufacturer. Only use parts that are approved by the manufacturer. Injury or death is a possible result of incorrect maintenance.
- Do a check of the product before use. See, Safety devices on the product on page 8 and Maintenance on page 15. Do not use a product that is damaged or does not operate correctly. Do the safety checks, maintenance and service instructions described in this manual.
- Children should be supervised to ensure that they
 do not play with the product. Never allow children or
 other persons not trained in the use of the product
 and/or the battery to use or service it. Local laws
 may regulate the age of the user.
- Keep the product in a locked area to prevent access for children or persons that are not approved.
- · Store the product out of reach of children.

- Under no circumstances may the design of the product be modified without the permission of the manufacturer. Always use original accessories. Nonauthorized modifications and/or accessories can result in serious personal injury or the death of the operator and others.
- The vibration emission during actual use of the power tool can differ from the declared total value depending on the ways in which the tool is used. Operators should identify safety measures to protect themselves that are based on an estimation of exposure in the actual conditions of use (taking account of all parts of the operating cycle such as the times when the tool is switched off and when it is running idle in addition to the trigger).

Note: National or Local laws can regulate the use. Comply to given regulations.

Safety instructions for operation



WARNING: Read the warning instructions that follow before you use the product.

- If you encounter a situation where you are uncertain how to proceed you should ask an expert. Contact your dealer or your service workshop. Avoid all usage which you consider to be beyond your capability.
- Never use the product if you are fatigued, while under the influence of alcohol or drugs, medication or anything that could affect your vision, alertness, coordination or judgment.
- Working in bad weather is tiring and often brings added risk. Due to the added risk, it is not recommended to use the machine in very bad weather, for instance in dense fog, heavy rain, strong winds, intense cold, risk of lightning, etc.
- Faulty cutting attachment can increase the risk of accidents.
- Do not allow children to use or be in the vicinity of the product. Since the product is easy to start, children may be able to start it if they are not kept under full surveillance. This can mean a risk of serious personal injury. Disconnect the battery when the product is not under close supervision.
- Ensure that no people or animals come closer than 15 meters while you work. When several operators are working in the same area the safety distance should be at least 15 meters. Otherwise there is a risk of serious personal injury. Stop the product immediately if anyone approaches. Never swing the product around without first checking behind you to make sure that no one is within the safety zone.
- Ensure that people, animals or other things can not affect your control of the product or that they do not come in contact with the cutting attachment or loose objects that are thrown out by the cutting

- attachment. However, do not use the product unless you are able to call for help in the event of an accident.
- Always inspect the working area. Remove all loose objects such as stones, broken glass, nails, steel wire, string, etcetera, that could be thrown out or become wrapped around the cutting attachment.
- Make sure that you can move and stand safely. Check the area around you for possible obstacles (roots, rocks, branches, ditches, etcetera) in case you have to move suddenly. Take great care when you work on sloping ground.
- Keep a good balance and a firm foothold at all times.
 Do not overreach.
- Deactivate the product before you move to another area. Attach the transport guard when the product is not in use.
- Never put the product down unless you have deactivated it. Do not leave the product unsupervised when it is switched on.
- Remove the battery before you pass the product to another person.
- Make sure that no clothes or parts of the body come in contact with the cutting attachment when the product is activated.
- If anything jams in the cutting attachment while you operate the product, stop and deactivate the product. Make sure that the cutting attachment stops completely. Remove the battery before you clean, inspect or repair the product and/or the cutting equipment.
- Keep your hands and feet away from the cutting attachment until it has stopped completely when the product is deactivated.
- Watch out for stumps of branches that can be thrown out when you cut. Do not cut to close to the ground where stones and other objects can be thrown out.
- Watch out for thrown objects. Always wear approved eye protection. Never lean over the cutting attachment guard. Stones, rubbish, etc., can be thrown up into the eyes which can cause blindness or serious injury.
- Listen out for warning signals or shouts when you wear hearing protection. Always remove your hearing protection as soon as the product stops.
- Never work from a ladder, stool or any other raised position that is not fully secured.
- This machine produces an electromagnetic field during operation. This field may under some circumstances interfere with active or passive medical implants. To reduce the risk of serious or fatal injury, we recommend persons with medical implants to consult their physician and the medical implant manufacturer before operating this machine.
- Always hold the product with both hands. Hold the product on the right side of your body.
- Always stop the product, remove the battery and make sure that the cutting equipment does not rotate before you remove material that is wound around the

blade shaft or caught between the guard and the cutting attachment.

- The electromagnetic field during operation can interfere with the active or passive medical implants. The persons with medical implants speak to your physician and the medical implant manufacturer before operating this product.
- Hold the weight of the product with the harness to make it easy to operate.
- Long-term exposure to noise can result in permanent hearing impairment. Husqvarna recommends that operators use approved hearing protection.
- Never use a product that has been modified in any way from its original specification.
- Never use a product that is faulty. Carry out the safety checks, maintenance and service instructions described in this manual. Some maintenance and service measures must be carried out by trained and qualified specialists. See instructions under the maintenance heading.
- Carry out an overall inspection of the product before use. See the maintenance schedule.
- Never allow anyone else to use the machine without first ensuring that they have read and understood the contents of the operator's manual.
- Check the working area for foreign objects such as electricity cables and animals, etc, or other objects that could damage the cutting attachment, such as metal items.
- · Faulty blades can increase the risk of accidents.

Personal protective equipment



WARNING: Read the warning instructions that follow before you use the product.

- Always use approved personal protective equipment when you use the product. Personal protective equipment cannot fully prevent injury but it decreases the degree of injury if an accident does occur. Let your dealer help you select the right equipment.
- Use a protective helmet where there is a risk of falling objects.
- Long term exposure to noise can result in damaged hearing. In general, battery powered products are relatively quiet but damage can result from a combination of noise level and long usage. Husqvarna recommends that operators use hearing protectors when using products for a longer coherent time of a day. Continual and regular users should have their hearing checked regularly.



WARNING: Hearing protectors limit the ability to hear sounds and warning signals.

- Use clothing made of a strong fabric. Always use heavy, long pants and long sleeves. Do not use loose clothing that can catch on twigs and branches. Do not wear jewelry, short pants, sandals or go with bare feet. Put your hair up safely above shoulder level.



To do a check of the user interface


- 1. Press and hold the start/stop button (A).
 - a) The product is on when the display (B) comes on.



- b) The product is off when the display goes off.
- If the warning indicator on the display is on or flashes, refer to Troubleshooting on page 17.

To do a check of the power trigger lockout


The power trigger lockout is designed to prevent accidental operation. When you push the power trigger lockout forward (A) and then press the power trigger lockout against the handle (B), the power trigger (C) is released. When you release the handle, the power trigger and the power trigger lockout both move back to their original positions. This movement is operated by three independent springs.




1. Make sure that the power trigger is locked when the lock is in its original position.



Push the power trigger lockout forward (A) and down. Hold the power trigger lockout against the handle (B) and make sure that it returns to its original position when you release it.



Make sure that the power trigger and the power trigger lockout moves freely and that the return springs operate properly.



- 4. Start the product, refer to *To start the product on page 12*.
- 5. Push the power trigger fully to apply full speed.
- 6. Release the power trigger and make sure that the cutting attachment stops and remains still.

To do a check of the bevel gear and gearbox



WARNING: To prevent burn injuries, let the product become cool before you touch the bevel gear and gearbox.

• Do a visual check for damage and deformation.

To do a check of the hand guard

The hand guard prevents hands from accidental contact with the blades.

1. Stop the product.

- 2. Remove the battery.
- 3. Check that the hand guard is attached correctly.
- 4. Examine the hand guard for damages.

To do a check of the blades

- 1. Stop the product.
- 2. Remove the battery.
- 3. Put on protective gloves.
- Make sure that the blades are not damaged or bent.
 Replace the blades if they are damaged or bent.

Battery safety



WARNING: Read the warning instructions that follow before you use the product.

- Only use the BLi200 or 40-B220X battery. Refer to Approved batteries on page 20. The battery is software encrypted.
- Use the BLi200 or 40-B220X battery that is rechargable as a power supply for the related Husqvarna products only. To prevent injury, do not use the battery as a power supply for other devices.
- Risk of electrical shock. Do not connect the battery terminals to keys, coins, screws or other metal. This can cause a short circuit of the battery.
- · Do not use non-rechargeable batteries.
- · Do not put objects into the air slots of the battery.
- Keep the battery away from sunlight, heat or open flame. The battery can cause burns and/or chemical burns.
- · Keep the battery away from rain and wet conditions.
- Keep the battery away from microwaves and high pressure.
- · Do not try to disassemble or break the battery.
- If the battery leaks, do not let the liquid touch your body or eyes. If you have touched the liquid, clean the area with a large quantity of water and soap, and get medical aid. If you get liquid in your eyes, do not rub but flush with water for a minimum of 15 minutes and get medical aid.
- Use the battery in temperatures between -10 °C (14 °F) and 40 °C (114 °F).
- Do not clean the battery or the battery charger with water. Refer to To clean the product, the battery and the battery charger on page 16.
- · Do not use a defective or damaged battery.
- Keep batteries in storage away from metal objects such as nails, screws or jewelry.
- Keep the battery away from children.

Battery charger safety



WARNING: Read the warning instructions that follow before you use the product.

- Risk of electrical shock or short circuit if the safety instructions are not obeyed.
- Do not use other battery chargers than the one supplied for your product. Only use Husqvarna chargers when you charge BLi200 replacement batteries.
- Do not try to disassemble the battery charger.
- · Do not use a defective or damaged battery charger.
- Do not lift the battery charger by the power cord. To disconnect the battery charger from a mains socket, pull out the plug. Do not pull the power cord.
- Keep all cables and extension leads away from water, oil and sharp edges. Make sure that the cable is not caught between objects, for example, doors, fences or equivalent.
- Do not use the battery charger near flammable materials or materials that can cause corrosion.
 Make sure that the battery charger is not covered.
 Pull out the plug to the battery charger if there is smoke or fire.
- Only charge the battery indoors in a location with good airflow and away from sunlight. Do not charge the battery outdoors. Do not charge the battery in wet conditions.
- Only use the battery charger where the temperature is between 5 °C (41 °F) and 40 °C (104 °F). Use the charger in an environment which has a good airflow, dry and free from dust.
- Do not put objects into the cooling slots of the battery charger.
- Do not connect the battery charger terminals to metal objects as this can short circuit the battery charger.
- Use approved mains sockets that are not damaged. Make sure that the cord of the battery charger is not damaged. If extension cables are used, make sure that the extension cables are not damaged.

- Remove the battery before you do maintenance, other checks or assemble the product.
- The operator must only do the maintenance and servicing shown in this operator's manual. Turn to your servicing dealer for maintenance and servicing of a larger extension.

- Do not clean the battery or the battery charger with water. Strong detergent can cause damage to the plastic.
- If you do not do maintenance, it decreases the life cycle of the product and increases the risk of accidents.
- Special training is necessary for all servicing and repair work, especially for the safety devices on the product. If not all checks in this operator's manual are approved after you have done maintenance, turn
- to your servicing dealer. We guarantee that there are professional repairs and servicing available for your product.
- Keep the teeth of the blade correctly sharpened.
 Obey our recommendations. Also refer to the instructions on the blade package.
- · Only use original spare parts.
- Always use heavy duty gloves when you repair the cutting attachment. The blades are very sharp and can easily cause injuries.




To install the handle
